Official Announcement from Sun Investment Savings and Loan:

TO WHOM IT MAY CONCERN:

Recently a number of international individuals or commercial entities that engage in illegal or unethical business practice had claimed that they are representatives of or in association with Sun Investment Savings and Loan, using our name and reputation to mislead and scam potential investors. Having obtained knowledge of these activities, we have repeatedly reminded our members to pay cautious attention and to double check with our administration office for the list of authorized agents or representatives.

In the newsletter of our C.E.O. that was released New Year's eve 2009, we again strongly warned our members about these scam activities. (Read "Scam Beware" excerpt from Sun Group C.E.O. News Letter Dec. 30, 2008 below). Our Absolute Non-Solicitation - No Upfront Fee Policy was also stated clearly following the Scam Beware notice in this newsletter.

Regardless of our efforts to warn and protect innocent people from falling in the trap of scammers who may use our name without authorization to cover their ill intentions, there are still people who believe in the scammers' game and promises without performing their best due diligence prior to scammers' program participation.

We have just been informed that there are individuals in California who were charged as scammers and have engaged in scamming business and attached our name to a part of their advertisement without our approval or knowledge. The result of their wrong-doing has caused serious damage to our reputation and standing with local authorities. Our management team has already retained a local law firm in California to represent us and to be in communication with the US SEC and local authorities to clear our name, and further, filing a complaint against these individuals and their accomplices to seek indemnity compensation for our business and personal damage.

Regarding the investment program of Sun Investment Savings and Loan, as a good standing Swedish legal economic entity we have the legal ability to offer investment to our registered, qualified members. The Management Team of Sun Investment Savings and Loan confirms with our members that your investment at our firm is safe and managed by our professional team with full responsibility and integrity. Please rest assured that you have made a good choice to be a member of a responsible and ethical organization. We are taking all measures to protect the safety of your funds and continue to honor our commitment as stated in the investment contract.

We will keep you updated on this matter.

- Recently there has been a surge of scam activities on the internet and through private and direct marketing of false promises for high return investment program from scam artists and so-called "High Yield Trading Expert" or "broker or facilitator of trading program". Many Sun Group members have been targeted for this purpose.
- In order to protect our members from being victim to these illegal activities, we are warning our members to double check with our administration office at: admin@suninvestsl.com to verify the authenticity of any program prior to sending money for investment participation.
- Sun Group is not responsible for any offer that is not officially confirmed by our Management Team.
- Sun Group is not responsible for any wrongdoing by those who claim to be Sun Group authorized agent or representative.
- Only qualified, registered Sun Group Members including Private Investment Clubs, Wholesale or Institutional Clients can participate directly in any Sun Group investment program.
- Sun Group is a legitimate, responsible company and at any time and under no circumstance would we involve or endorse any person or any program that is in association with scam artist or scam programs.
- For the best protection of our company and our members, we encourage our members to report suspicious illegal activities to local authorities.

Absolute Non-Solicitation - No Upfront Fee Policy:

- We want to remind you of our Absolute Non-Solicitation Policy.
- Sun Group is direct provider. We manage our own trading platform with our own investment program.
- Upon completion of the first initial review and due diligence of any project and it is of interest, then our underwriting department will work directly with the principles involved to provide further instruction on how to proceed for project completion.
- We never charge any up front fee. None of our authorized agent or representative is allowed to charge any up front service fee. Be careful for those who asks you to pay an upfront service fee; they certainly are either scam artist or "fakes and not our authorized agent".
